### Dane County Tax Deed Auction Bid Form Instructions

- Bids will be accepted starting 6 weeks before the bid opening date. The following are criteria used in awarding bids:
  - Only bids at or exceeding the appraised value;
  - Only bidders with no unpaid real estate delinquencies in Dane County;<sup>1</sup>
  - Only bidders not involved with the tax deed process administration (auction included);
  - Dollar amount of the bid;
  - o Bidder access to the property; and
  - Earliest received bid (if all other criteria equal).

- In a separate, sealed envelope, each bid must include a completed <u>bid form</u> enclosed with <u>10% of</u> <u>the bid for earnest deposit</u> for each bid for each parcel and clearly addressed in the following format:

- Ten percent (10%) of the bid for earnest deposit and the balance of the successful bid will only be accepted in the form of cash or cashier's check.

The following information is required on bid forms if an agent is representing a bidder:

- The successful bidder will be sent notification within forty-eight (48) hours of the subject bid opening. The notice will be sent via certified mail to the successful bidder (or representative of the bidder if applicable) as identified on the bid form. All other deposits will be returned to the respective bidders. Please be advised that US Postal Service delivery time may vary.
- All purchase transactions must be completed within ten (10) days of receiving the bid award notification letter. If there is a default, the 10% earnest money will be kept by Dane County, and the Dane County Treasurer will send notice within forty-eight (48) hours to the next successful bidder.

<sup>&</sup>lt;sup>1</sup> If the Bidder is a Limited Liability Company, Corporation, or any other type of business entity, then its bid will only be accepted if no member, stockholder, or other owner of the business entity has any delinquent real estate taxes in Dane County, and no other business entity owned by any member, stockholder, or other owner of the Bidder has any delinquent real estate taxes in Dane County. BidForm
