## Dane County Tax Deed Auction

Pursuant to Wis. Stats. §75.69(1) and Dane Co. Ord. Ch. 26.18, the Dane County Treasurer hereby causes publication of this notice to identify each tax deeded parcel for sale (parcel no. & property address), its appraised value (minimum bid), the deadline for submitting a bid to purchase (bid due), and when the sealed bids will be opened (bid opening). Bids will be awarded according to the following criteria: **only bids at or exceeding the appraised value, only bidders with no unpaid real estate delinquencies in Dane County, only bidders not involved with the tax deed process administration, dollar amount of the bid, bidder access to the property, and earliest received bid (all other criteria equal)**.
